# Terms and conditions for publishing houses and representation agencies

The *Associació de Professionals de la Il·lustració Valenciana – APIV*, in collaboration with *FULL Fundació pel Llibre i la Lectura*, present “Audicions!”, a professional interviews event aimed at illustrators, publishers and artists agencies. It will take place on December 13th and 14th 2022. It will be a virtual event for two reasons: 1) to increase the participation of international publishers and agencies and 2) to carry out the activity while ensuring the safety of each participant in accordance with the applicable health recommendations.

### Categories of participation

Participants can be:

1. Publishers of illustration works.
2. Illustration agencies.

### Registration

Registration is free.

Until October 23rd 2022 at 11.59 p.m. (CET/UTC+1).

### Registration process

The process will consist of two phases:

#### 1. Registration for the event

Until October 23rd 2022 at 11.59 p.m. (CET/UTC+1).

Participants must correctly fill in the registration form for this call on the “Participate” section of [www.babakamo.com](http://www.babakamo.com)

The following steps will be carried out on the “Audicions!” page on the B2Match platform.

The organization will create the selected participants’ profiles on the platform and provide the access data to them. Participants (individuals and companies) will have to complete their profile data (contact details, link to their work, etc).

Participants will also have to set up the time slot correctly, as there will be participants from all over the world.

#### 2. Application for interviews and agendas

From November 17th at 9.00 a.m. (CET/UTC+1) to December 1st at 11.59 p.m. (CET/UTC+1).

Once the registration is closed, participants will be able to request interviews. Publishers and agencies may accept or reject applications according to their criteria and editorial line. This will ensure that interviews are only held between mutually interested parties.

Due to the high demand for participation by illustrators, and with the suggestions collected in the evaluation survey of the previous edition, the organization has decided to separate the registration periods. In this way, depending on the participating publishers and representation agencies, the total number of subsequent registrations of illustrators will be more or less limited in order to make reasonable agendas and with the availability of sufficient time to carry out productive and helpful meetings.

This way, once the illustrators have registered, as of November 17th, publishers and agencies are committed to responding to all applications, whether they accept or reject them.

When applications are accepted, they will be added to the schedule of each participant. It will be available on the platform at all times.

### **Interviews**

Interviews will be held virtually, through the video conferencing tool on the B2Match platform. Therefore, it is recommended to update your browser and to check that the camera and microphone are working properly beforehand.

In addition, when planning interviews between speakers of different languages, it is recommended to agree beforehand on the language to be used to foresee if the help of an interpreter will be needed. The organisation will not be responsible for any arrangements or costs related to this issue.

### **Selection of participants**

The selection of illustrators will be carried out by the participating publishers and agencies.

The organisation will not be responsible for this selection.

### **Responsibility**

Publishers and agencies agree to respect the good practices recommended by APIV and the intellectual property. Requests for free trials or offers of unpaid work will not be accepted.
